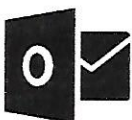

REQUEST:

The Township of Hornepayne (the town) received an access request pursuant to the *Act* as follows:

1. Results of soil sampling done by [specific company] of Thunder Bay.

2. Minutes of meetings between Hornepayne, [specific company] and MOE concerning contamination on and off [specific company] property.
3. Other related correspondence (all).

DECISION:

The town issued a decision indicating that they searched its records and does not have records in its care and control relating to the request.

APPEAL:

The requester (now the appellant), appealed the town's decision.

RESULTS OF MEDIATION:

During the mediation, the mediator had several discussions with the appellant and the town. The mediator discussed the request and the town's decision.

The appellant raised the issue of search, articulating his belief that further records may exist.

The mediator conveyed the appellant's concerns to the town. The town agreed to conduct a secondary search. The town issued a supplementary decision letter to the appellant and provided the appellant with further records.

After reviewing the information, the appellant subsequently decided that he no longer wished to pursue this appeal.

Accordingly, this file is now closed.
